These trailers are custom built to provide both an Operations Center and Living Quarters for our team when deployed to a site to allow them to provide 24 hour on-site rescue and EMS availability working 12 hour shifts on-duty and 12-hour shifts on-call while quartered on-site within the MRC. This concept has proven extremely effective and popular with our clients as a result of the same professional service they

have come to expect from us twenty-four hours a day at a substantially lower cost than contracting standard 24-hour rescue service coverage. While on-site our rescuers conduct themselves in a highly professional manner and comply with all client code of conduct and safety rules whether on-duty or on-call quartered within the MRC.
